Sports Massage is the specific application of systematic manipulation of the soft tissues of the body for therapeutic purposes.

The course introduces to participants the applications of massage in various sports settings, describes commonly used techniques and the theory behind the practice.

This course equips participants with the wonderful techniques of sports massage, which helps athletes by warming up their muscles and joints. Muscles that are properly massaged and stretched possess the ability to generate more power because of its greater elasticity, which translates to its ability to absorb more shock, resulting in lower risk of injury.

Target Audience

Physical Education teachers, coaches, athletes, and anyone who wish to acquire basic sports massage techniques.

Total Duration of 42 hours + 10 hours practicum

- (c) Dress code

During the course, participants will be required to remove part of their attire i.e the T-shirt. For professionalism and modesty reasons, all participants must be suitably dressed in comfortable sports attire, (shorts, T-shirts and sports shoes). It is recommended for ladies to wear a sports bra-top.

Sporting footwear (e.g. running shoes, cross-trainers...etc) should be worn at all times. No jeans, bermudas, slippers, sandals, beach wear, platform shoes or high heels should be worn during lessons.

All participants are required to trim their fingernails prior to the class. They should also remove any jewellery and watches from their hands during the practical sessions to prevent injury.

() I agree to abide by the above dress code throughout the whole course.

- (d) Attendance

All participants are required to achieve **a minimum of 85% attendance** to qualify for examinations. Attendance is compulsory for the first session, the hands-on attachment as well as the theory and practical examinations.

For request on deferment of class due to unforeseen circumstances, please provide the relevant documents and/or certified letters to justify, subject to approval. For absence due to medical reasons, please provide a valid medical certificate.

(e) Re-examination

Prior to the examination certification, should participants fail or be absent from the theory and / or practical examinations without a valid reason, a **re-examination fee of S\$50.00** (either theory or practical) will be chargeable. Please provide a certified proof of absence.

The re-examination date for both Theory & Practical will be scheduled approximately 3 weeks from the day of the results announcement.

Participant who is unavailable for the scheduled re-test date will join the test conducted for the next intake, schedule to be advised by course administrator. SSC will not be able to re-schedule or conduct additional re-examinations in-between.
